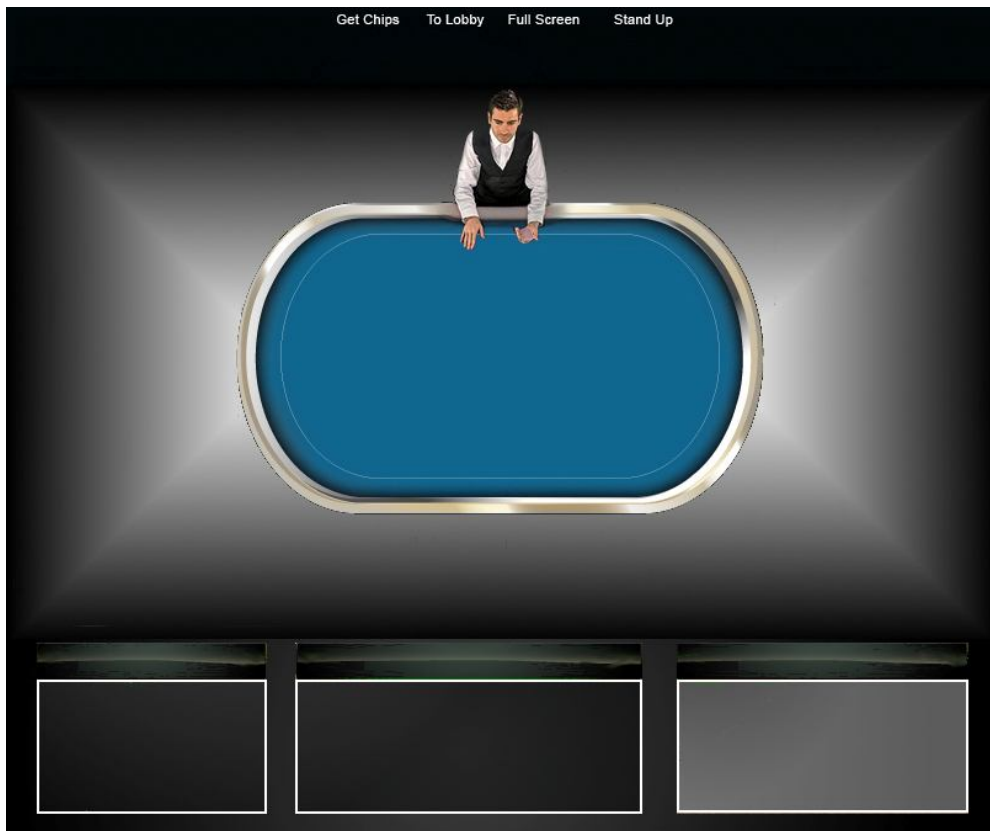

LEGAL OPINION:

Judge in New York says poker is not gambling under federal law

NEW YORK – A federal judge in New York has handed a victory to poker advocates, ruling the card game isn't gambling under federal law because it's primarily a game of skill, not chance.

The decision Tuesday by Judge Jack Weinstein in Brooklyn is likely to be embraced by advocates of card games who are pushing to legalize Internet poker in the United States.

The ruling resulted in the dismissal of a federal criminal indictment against a man convicted last month of conspiring to operate an illegal underground poker club. The judge relied in his decision largely on findings by a defense expert who analyzed Internet poker games.

The judge noted the federal statute was created to combat organized crime.

THE GAME CONSISTS OF 2 ELEMENTS:

A. The 1st part is a 6 ½ day per week "Sit N Go" poker tournament where the player can effectively increase their odds as they proceed to the 2nd part of the program, the Pick-6 drawing.

B. Part 2 of the program, the Pick-6 drawing, where players redeem their points for Pick-6 tickets allows for increased chances of winning the weekly Drawing, as points earned in the poker tournament can be redeemed for Pick-6 Tickets.

The Player buys Poker Play Tickets for \$ 1.00 USD each that come with 50,000 play chips. Each ticket can either be redeemed immediately for a single ticket in the weekly Pick-6 lottery game, or optionally be used to enter the weekly poker tournament. The player may continue to play poker as often as they wish until they either lose the 50,000 points, or can continue to play until they have earned enough poker points to convert to multiple Pick-6 Tickets.

Each week's Top Poker Tournament winner will be rewarded with an additional 100 Pick-6 tickets, along with a promotional prize, and the 2nd place winner will be rewarded with an additional 50 Pick-6 tickets.

As players achieve more poker points, they may redeem them for one Pick-6 ticket per 50,000 poker points.

TICKET SALES DISTRIBUTION:

The ticket purchase dollar will be distributed as follows: 40% is applied to the Winner(s) of the Weekly Pick-6 Drawing, 5% is given to the country of the player's registration, and 40% is applied to a College IT Scholarship Fund. Scholarships are awarded to students from the country where player registered and are based on applications presented to that country's Minister of Education.
